Authorizations

Ensure compliance with deadlines and procedures

- Assist businesses and investors to obtain authorizations for investment projects exceeding 15M TND
- Claim the consideration of authorizations' applications in case of silence of the competent administrations, with a view to guarantee compliance with deadlines
- Monitor coordination between businesses and investors and the different relevant organizations

Project Declaration

Swift implementation of your investment project

- Assist businesses and investors in the project declaration process (creation, extension, renewal) and ensure the delivery of the declaration certificate within one working day¹
- Assist businesses and investors during the process of modifying the project declaration
